## **Forest County Board meets**

The full Forest County Board met last Tuesday, November 13, in the Forest County Board Room, and discussed and passed a number of resolutions. In a nutshell:

The Forest County budget was unanimously approved for 2019.

The forestry work plan was unanimously approved.

The ADRC was given a unanimous go ahead to continue the program along with Taylor County after Oneida and Vilas Counties had pulled out.

All agreed that they were against adding another sex offender in the house near Mole Lake who is not from Forest County.

It was agreed by all that repairs should be made on delinquent tax properties to maintain the value of the property to help keep up the value of the properties. All board members but one agreed to take the money from the general fund, with the dissenter wanting to borrow the money. The repairs are for the maintenance of county property, such as roof repairs and general maintenance.

There are a number of snowmobile trail bridges that were studied the engineering firm of MSA and found to be in better shape than the DNR had thought. Another DNR report is still coming. A \$10,000 donation was proposed by the county to help buy a lighter groomer, but the Board voted to table this proposal until more info is available.


The Forestry Department was given the go-ahead to start the process to buy the Bonack land purchase on County S, on the west side of the road and bordered by County S on the east and the railroad tracks on the south. This process will include a DNR Project Loan and an application for a Stewardship Grant to cover half the coast. If the applications are approved, Forest County will take ownership of 400 plus acres of forest land.

There was a unanimous vote to charge the state for law enforcement on the two Indian reservations in the county. This is due to federal legislation transferring iurisdiction over Indian criminal matters to the state, so it was unanimous by the board to bill the state for county law enforcement.

The last item on the agenda was whether or not to charge a penalty on delinquent taxes of .5% delinquent tax bills per month of delinquency.

The board was adjourned.

The Forest County Building Committee met in the county board room last Wednesday, November 14th, and the meeting was just attended by county board members of the committee and citizen members, as well as some spectators. The purpose was to have a discussion without input by an architect or planner and discuss priorities.

Chairman Tallier discussed having a flow chart on the project to help give direction to this effort.

Some priorities were discussed on the project, and the meeting went very well without interruption from planners or architects.

It should be added that there has been difficulty having a meeting and discussing priorities and suggested plans with the outside advice. When a drawing is made by a board member, given to the architectural firm, a schematic drawing comes back to the next meeting that is

Winter seems to have come to stay. Snow covers the ground and many lakes have started to freeze over. To some winter is a curse, to others they cannot wait until this time of year.

To Forest County, winter brings a boom to business in the form of snowmobilers and ice fishermen which frequent our gas stations for fuel, snacks, beverages, and bait. These same sportsmen also frequent our bars and restaurants for food, drinks and heat! Some

Timber sale levels on the Chequamegon-Nicolet National Forest (CNNF) increase for the sixth year in a row. In fiscal year 2018, which is from October 1 to September 30, the Forest sold 128.7 MMBF of timber through the competitive timber sale bidding process.

"The Forest hasn't sold 128 MMBF of timber since the early 1990s," said Paul Strong, Forest Supervisor, Chequamegon-Nicolet National Forest. "I am very proud of the great staff and partners we have in making this achievement possible."

In addition to the Forest's regular timber sale program, which sold 98 MMBF this year, 30.7 MMBF was sold through the Good Neighbor Authority agreement with the Wisconsin Department of Natural Resources.

"The 2014 Farm Bill permanently authorized Good Neighbor Authority as well as Stewardship Contracting and the Forest continues to leverage them to increase timber sales and sustainable forest management activities on the National Forest," said Strong. "We appreciate everyone who has contributed to the success of the Forest's timber program and ultimately the management of National Forest system lands in northern Wisconsin."

In 2017, the Forest sold 120.5 MMBF of timber for an estimated value of \$7.72 million. Contractors also

### Office on Aging offers Three Strong Bodies Classes starting in January

This wasn't a long, drawn out meeting, as the committee was able to get down to business with little interruption.

All agreed that the 911 dispatch in the Law Enforcement was top priority, and it was moved to send out proposals to all architects.

There was a motion to move forward on obtaining a structural analysis on the old jail and sheriff's residence, including the foundation. There was also a motion made to solicit bids on the lead paint and asbestos removal on this old structure, as well as the cost of demolition of interior walls to the studs, and the motion carried.

There was another motion agreed on to have citizen committee Lamer and head maintenance man Rhinehardt look into construction firms for contracting the 911 work.

There was also a motion to get some pricing ideas on the cost of a new courtroom and other new structures.

This was a down to business meeting, and there is an effort to meet the county's needs while staying at a price the taxpayers can afford.


He was the oldest of three children born to Mildred (Pahnke) and Lester Gilson in Green Bay, Wisconsin. He graduated from

## Self-sample kits available at Rhinelander and Antigo DNR service and satellite centers

CWD self-sample testing kits are available at the Rhinelander DNR Service Center as well as the Antigo DNR Satellite Center. These kits include all supplies and instruction necessary for hunters to collect CWD lymph node samples from harvested deer, and a prepaid envelope for mailing samples to the DNR CWD Processing Center. These kits are free and are distributed on a first come, first served basis while supplies last.

If CWD test results come back positive for CWD, hunters should follow advice from the Center for Disease Control, Wisconsin Department of Health Services and World Health Organization to not consume venison from that deer.

#### Sick deer reports:

DNR staff are interested in reports of sick deer or deer with an unknown cause of death, but it is important to note that they are not currently examining car-killed deer. Contact your local DNR wildlife biologist to report a sick or dead deer or call the DNR's Customer Service hotline at 1-800-847-9367.





Prejudice or discrimination of a person based on his or her age, also known as agism, is deeply ingrained in our culture. There is oftentimes a fear of getting older. It is easy to find things making fun of aging, such as birthday cards and over-the-hill decorations. Our society's obsession with youth can be found in the media where young people are used in advertising and marketing of travel and cars, despite the fact that older adults travel and purchase cars more often than younger people.

Even public spaces can inadvertently discriminate against older people. For example, loud or dimly lit restaurants can be difficult for older people to visit. Places without handrails can be challenging for older people to visit as well.

Those who embrace aging with a "yes, I can!" attitude are more likely to have better brain performance and memory, have a greater sense of control over their lives, are less likely to have a hearing decline, and are more likely to get preventive care. People with a positive perception on aging are also 44% more likely to recover from disabilities.

It is possible to be unaware of your ageist statements. Saying things like, "wow, she looks good for her age" is ageist because it gives the impression that being older is a bad thing. It is beneficial to all to call out ageism like this when we see it. 

businesses in Forest County rely on winter for over 50% of their income which comes over a 2-3 month season. Winter is important to Forest County and we welcome all the winter enthusiast.

A lot of the efforts of this office are spent in identifying and beginning control of invasive species that are located in the County. Forest County does have issues with invasive species in certain locations and our lakes and forest seem to be under attack by various species both aquatic species (water species) and terrestrial species (land species)

Species such as the Eurasian Water Milfoil, Zebra Mussel and the Spiny Water Flea have only begun their attack on Forest County Lakes. These species are often transferred from site to site by water in bait buckets. To protect the lakes and streams of Forest County, please buy bait locally and retain all water in your bait buckets, do not empty them on the ice or in the water.

Although not usually in the spotlight at this time of the year, we must also be careful of the equipment that we use. Loggers and contractors know this well and are required to address the issue before moving to a new area. Often times snowmobiles, ATVs and sleds utilized to carry winter equipment are pulled and operated through all kinds of "weeds" and dry vegetation. This dry vegetation usually has ripe seeds that are ready to fall, when they fall on equipment, they can be spread over long distances by trailer or vehicle. Once brought to a new area with frozen snow or ice, the seeds can travel a long way with the wind moving them.

Of a particular concern to Forest County is a species called phragmites. phragmites is a large grass that overtakes areas, especially on wetter ground and in wetlands. Most have seen phragmites lining the ditchs along Hwy 141 near Green Bay. Phragmites is very common in counties to the south and east, including Marinette, Oconto, Brown and Outagamie to name a few. Forest County has the advantage in that this species has only been located and controlled in a very few locations. Once pharagmites is established it spreads rapidly and is very costly to control.

Many other species of invasive plants can also be transported by seed. To protect the forest and wetlands of Forest County, please clean your recreational equipment by washing it or blowing it free of debris using an air compressor before you travel long distances. This will limit the transfer of invasive species seeds that could cause a new infestation, wherever you may go.

Currently, there are seven timber sales available for bidding with various bid due dates. For a list of sales and to learn more about the Forest's timber sale program please visit https://go.usa.gov/xPVXS.

The continual increase in timber sales on the Chequamegon-Nicolet provides more wood to Wisconsin's important forest products industry, while creating and maintaining healthy forest conditions prescribed in the Forest's 2004 Land and Resource Management Plan (LRMP).

Of the more than 860,000 acres of land suitable for commercial timber harvest on the National Forest, 13,943 acres experienced a harvest in 2018. The remaining portion of the 1.5 million acres of the Forest is considered unsuitable because of wetlands, steep slopes, Wilderness or recreation designations or ecological/research areas.

Timber purchasers typically have two to three years to complete harvest operations after purchasing a sale. As of July 2018, the Forest currently has approximately 27,000 acres under timber sale contract that are available for harvesting.


