## Forest County issues guidance on COVID-19 Safe Practices

On Wednesday, May 13th, the Wisconsin Supreme Court issued a decision invalidating the Safer at Home Order. In response to this ruling, Forest County continues to work with local partners on a plan to keep all residents safe and healthy.

The Forest County Health Department will continue to closely monitor the COVID-19 pandemic and has the obligation to respond to any outbreaks and spikes in cases that may occur. Should Forest County see significant outbreaks, countywide transmission or deaths due to the virus, the Forest County Health Department is prepared to respond and local orders may be issued accordingly. "It is our job to protect the health and safety of all residents of Forest County and take appropriate action as necessary," said Jacee Shepard, Forest County Health Officer.

The order is gone, the virus is not. We ask all community members to continue to follow the guidance that has been shared over the last eight weeks to ensure their own personal health and safety, along with the health and safety of their families, friends, and fellow community members. Maintain physical distance, avoid gathering in groups, practice good personal hygiene, limit travel to reduce potential of virus transmission, consider wearing a mask or cloth face covering in public, and stay home if you are ill. Do not go to work, the store, or anywhere else if you are experiencing any COVID-19 symptoms. People who are vulnerable and at higher risk of severe complications of COVID-19 should stay home whenever possible. If you are experiencing any symptoms, please call your health care provider and ask to be tested.

Our local businesses, non-profits, and other entities play a significant role in helping to keep our community healthy and safe. If a business chooses to be open, we strongly advise them to implement the strategies and practices provided in the Wisconsin Economic Development Corporation (WEDC) Reopening Guidelines at <https://wedc.org/reopen-guidelines/>, the Centers for Disease Control at <https://www.cdc.gov/coronavirus/2019-ncov/index.html>, and the Wisconsin Department of Health Services at <https://www.dhs.wisconsin.gov/covid-19/index.htm>. We also encourage businesses to develop a COVID-19 plan that includes screening staff for illness, disinfecting/cleaning protocols and proper physical distancing considerations for customers and employees. Please consult with the Forest County Chamber of Commerce and the Forest County Health Department to gather additional information to safely resume business activities.

## 11 cases of Covid-19 confirmed in Forest County

Forest County Public Health officials have confirmed a total of eleven people have been diagnosed with novel coronavirus infection (COVID-19) in Forest County. The individuals are linked to the current public health investigation with The Bay at Nu-Roc.

We continue to work closely with The Bay at Nu-Roc leadership and staff to ensure all appropriate measures are in place to keep the residents and staff safe and healthy.

The Forest County Health Department continues to encourage community members to minimize their contact with others by staying home when possible, practice physical distancing, and stay alert for symptoms of COVID-19.

Community members experiencing any of the following symptoms should call their health care provider and ask to be tested: Fever, Cough, Shortness of breath, Sore throat, Headache, Fatigue, Body or muscle aches, Nausea, Vomiting, Diarrhea, Loss of smell, Loss of taste.

In an effort to keep community members up to date on COVID-19, the Forest County Health Department will continue to update our Facebook page daily with current COVID-19 case counts. This will include the number of negative and positive cases in Forest County.

## Wisconsin Supreme Court decision regarding safer at home

We understand that Forest County residents are likely to have questions following the announcement from the Wisconsin Supreme Court invalidating the Safer at Home Order.

### Baldwin Announces \$1.5 Million for Wisconsin Manufacturers to Respond to COVID-19 Pandemic

#### The Bipartisan CARES Act Includes \$50 Million to Support Manufacturing During the Pandemic

WASHINGTON, D.C. U.S. Senator Tammy Baldwin today announced that the Wisconsin Center for Manufacturing and Productivity will receive \$1.5 million for manufacturers to prevent, prepare for, and respond to the COVID-19 pandemic. This funding comes as part of the bipartisan Coronavirus Aid, Relief, and Economic Security Act (CARES) Act that passed Congress in March and was signed into law by President Trump.

"The COVID-19 pandemic has created an economic crisis that is hurting our Wisconsin manufacturers," said Senator Baldwin. "I supported the bipartisan CARES Act because it provides critically needed federal funding to support our manufacturing businesses and workers, and gives them the tools they need to keep moving our Made in Wisconsin economy forward."

**Nicolet to offer new, all-online  
University Transfer degree;  
COVID-19 could keep Northwoods students  
closer to home**

Northwoods students interested in earning a bachelor's degree can now complete the first half of that credential entirely online with classes starting at Nicolet College this fall.

"We've been working towards this goal and now have all of the courses online that students will need to complete their two-year associate's of arts degree," said Nicolet University Transfer Liberal Arts Dean Laura Wind-Norton.

"This is an excellent option for students who need the flexibility online classes offer and also for those who simply prefer online learning."

The 60-credit college credential transfers to all University of Wisconsin campuses, including UW-Madison and UW-Milwaukee, as well as many other colleges, both public and private.

Wind-Norton also noted Nicolet also has an extensive history of delivering online instruction, going back more than 15 years, allowing the college to continually refine instructional methods and personalize the experience for each individual.

"That means we are at a point where we can continuously improve our online offerings and interaction rather than just learning to develop online courses," she said. "Our instructors are committed to ongoing professional development in online learning. Students have direct interaction with their instructors, instructors who live in the same communities and know the unique challenges that sometimes come with living in rural areas. 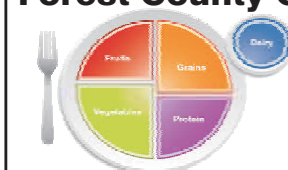

duration and restrictions of the COVID-19 pandemic. These \$2,500 cash grants will assist with the costs of business interruption or for health and safety improvements, wages and salaries, rent, mortgages, and inventory. Businesses will be able to apply for grant assistance in early June.  
Wisconsin small businesses have stepped up during this pandemic to keep people safe and many have pivoted to producing needed items such as hand sanitizer and face coverings. Providing relief to small businesses in Wisconsin that have been impacted by the pandemic is an important part of our response to and recovery from the pandemic.

"Wisconsinites have done an incredible job of banding together throughout this crisis and it's more important than ever for us to continue respecting each other, supporting each other, holding each other accountable and protecting those who are vulnerable," Gov. Evers said. 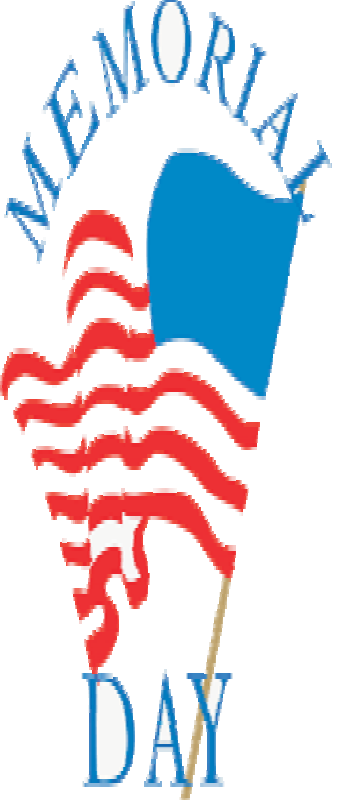

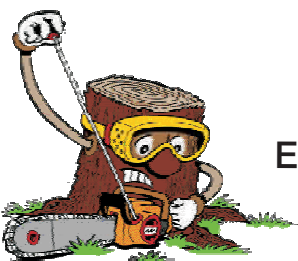

## USDA reports record enrollment in Key Farm Safety-Net programs

WASHINGTON, April 27, 2020 Producers signed a record 1.77 million contracts for the U.S. Department of Agriculture's Agriculture Risk Coverage (ARC) and Price Loss Coverage (PLC) programs for the 2019 crop year, which is more than 107 percent of the total contracts signed compared with a 5-year average. USDA also reminds producers that June 30 is the deadline to enroll in ARC and PLC for the 2020 crop year.

"Producers for several years have experienced low commodity prices, a volatile trade environment and catastrophic natural disasters," said Richard Fordyce, Administrator of USDA's Farm Service Agency (FSA). "Farmers looking to mitigate these risks recognize that ARC and PLC provide the financial protections they need to weather substantial drops in crop prices or revenues."

Producers interested in enrolling for 2020 should contact their FSA county office. Producers must enroll by June 30 and make their one-time update to PLC payment yields by September 30.

FSA attributes the significant participation in the 2019 crop year ARC and PLC programs to increased producer interest in the programs under the 2018 Farm Bill and to an increase in eligible farms because of the selling and buying of farms and new opportunities for beginning farmers and military veterans with farms having 10 or fewer base acres. Enrollment for 2019 ended March 16.

USDA Service Centers, including FSA county offices, are open for business by phone only, and field work will continue with appropriate social distancing. While program delivery staff will continue to come into the office, they will be working with producers by phone and using online tools whenever possible. All Service Center visitors wishing to conduct business with the FSA, Natural Resources Conservation Service or any other Service Center agency are required to call their Service Center to schedule a phone appointment.
