699 cases of Covid-19 (61 active) confirmed in Forest County

Forest County Public Health officials have confirmed additional persons have been diagnosed with novel coronavirus infection (COVID-19) for a total of 699 cases in Forest County. County health officials and local partners are contacting others with whom the individuals who tested positive had close contact with. As of today, Forest County has 3,462 negative test results. There are currently 61 active cases in isolation, 616 released from isolation, 6 hospitalized, and 16 deaths.

The Forest County Health Department encourages community members to minimize their contact with others by staying home when possible, practice physical distancing and good personal hygiene, wear a mask or cloth face covering, and stay alert for symptoms of COVID-19. If you are experiencing any symptoms or have been exposed to someone with COVID-19, please contact your health care provider and ask to be tested.

In an effort to keep our community members up to date on COVID-19, the Forest County Health Department will continue to update our Facebook page daily and local newspapers weekly with current COVID-19 case counts. This will include the number of negative and positive cases in Forest County. Please call our office at 715-478-3371 with any questions or concerns.

As we get closer to Winter and temperatures drop, many of our nonmigrating animals will hibernate. Hibernation is an animal adaptation to seasonal changes, such as low temperatures, a shortage of food, or snow cover.

Why do animals hibernate?

Snow, temperatures, and food shortages are the main factors, but is there something in an animal's biology that tells the body to hibernate? Scientists have found a substance in hibernating animals' blood that they call a Hibernation Induced Trigger (HIT). This substance has even been studied to be used in humans to put one in a hibernation-like state so severely injured or sick people can heal faster

What are "True" Hibernators?

The animals that fall in this category, such as woodchucks, ground squirrels, and bats, are the species that truly fall into cycles of deep, comatose-like sleep throughout the winter. Woodchucks, for example, drop their heart rate from 80 beats per minute to 4 beats per minute when in hibernation! Their body temperature also drops from 98 degrees Fahrenheit to 38 degrees! 
Clifford loved listening to country music and spending time



cycles, true hibernators get up every few days or weeks to eat. Groundhogs wake up about 12-20 times during hibernation.

Light Sleepers:

These animals, like bears, skunks, raccoons, and opossums, lower their body temperature only a few degrees and breathe a little more slowly than normal. Bears will not eat, drink, defecate, or urinate during hibernation and they cut their metabolic rate by 50 - 60%. Bears will live off the layer of fat that they put on during the months leading up to winter. During hibernation, they will recycle urea (the byproduct of metabolizing fat) into protein. This nitrogen recycling is why scientists call them "super hibernators". Losing fat and building protein during hibernation allows them to maintain muscle mass and organ tissues.


Cold-Blooded Animals:

Cold-blooded animals like snakes, turtles, and frogs all hibernate during the winter as well. Cold-blooded animals cannot regulate their body temperatures, so they must find a place to protect themselves from the cold. Frogs and turtles will bury themselves in mud below the frostline. Snakes gather together in rotting logs, tree stumps, or rock piles to stay warm.

What about Climate Change and Hibernation?

The warmer winters do have a negative effect on hibernators. Warmer temperatures arouse animals from hibernation more often and they stay active longer during these breaks in hibernation. The cycles of waking use the most energy during hibernation and can lead to starvation.





Milwaukee, WI (November 20, 2020) – The USDA Forest Service Eastern Region is seeking public feedback on a proposed list of deferred maintenance projects selected for Great American Outdoors Act funding in fiscal year 2022.

The Eastern Region's project list can be found on the Eastern Region Great American Outdoors Act Projects webpage. These projects aim to address the agency's \$5.2 billion deferred maintenance backlog and improve public access and quality of visitor experience through repair and restoration of roads, trails, bridges, recreation sites, and other facilities.

The proposed projects were selected based on seven criteria:

- Reducing deferred maintenance
- Promoting management of America's forests



•Background

The Great American Outdoors Act responds to the growing \$5 billion backlog of deferred maintenance on national forest and grasslands, which includes \$3.7 billion for roads and bridges and \$1.5 billion for visitor centers, campgrounds and other facilities. The Forest Service currently administers more than 370,000 miles of roads, 13,400 bridges, 159,000 miles of trails, 1,700 dams and reservoirs, 1,500 communications sites, 27,000 recreation sites, and 40,000 facilities of other types. In addition to helping address deferred maintenance for these critical facilities and infrastructure, the Great American Outdoors Act will help the Forest Service to continue supporting rural economies and communities in and around national forests and grasslands across the country.







Chequamegon-Nicolet receives Regional Awards for storm recovery projects

(Rhinelander, WI, November 20, 2020) – The Chequamegon-Nicolet National Forest received two awards this week for storm recovery efforts on the Great Divide and Lakewood-Laona Ranger Districts. The Eastern Regional Forester's Honor Awards recognized outstanding achievements during fiscal year 2020, which ended Sept. 30.

"Recovery from these storms took collaboration across the forest and partnership with other agencies," said Dawn Laybolt, Acting Forest Supervisor. "It's gratifying to see the individuals and teams recognized for their hard work. We commend them all."

The Great Divide Ranger District received an

award for its work toward facilitating rural prosperity and economic development. The district recently completed a four-year effort to recover from severe weather in July 2016 that caused over \$22 million in flood damage to roads, trails, culverts and bridges.

Immediately after the storm, the district made

emergency repairs to restore critical thoroughfares and access for residents who rely on Forest Service roads. In the years since, the district worked with the U.S. Department of Transportation, Federal Highway Administration's Eastern Federal Lands Highway Division to implement permanent repairs and sustainable improvements to the Forest infrastructure.

The Lakewood-Laona Ranger District received an award for its productive and sustainable use of National Forest lands following a July 2019 windstorm that damaged trees on more than 100,000 acres. In fiscal year 2020, the Chequamegon-Nicolet National Forest was the top timber producing national forest in the country, due in large part to the salvage operations from this storm.

The forest's Good Neighbor Authority agreement with the Wisconsin Department of Natural Resources provided additional capacity for promptly awarding and adjusting timber sales. Partnership with the DNR also allowed for more efficient fire prevention and suppression efforts, communication with counties and residents, and sharing of maps, imagery and other critical data.

Regional Forester Honor Awards recognize significant contributions to upholding the Forest Service mission of sustaining the health, diversity and productivity of the nation's forests and grasslands and to meet the needs of present and future generations.

Baldwin, Colleagues Urge Robust Funding for State and Local Governments to Distribute COVID-19 Vaccines

Public health experts have estimated that a minimum of \$8.4 billion is needed for COVID-19 vaccine distribution efforts

WASHINGTON, D.C. – U.S. Senator Tammy

WASHINGTON, D.C. – U.S. Senator Tammy Baldwin today joined her colleagues, led by Senator Cory Booker (D-NJ), in urging Congressional leaders to provide robust funding to ensure the swift distribution of COVID-19 vaccines as a part of any upcoming legislation to address the pandemic.

Recent reports indicate that several COVID-19 vaccine candidates have demonstrated encouraging safety and efficacy data, and the Food and Drug Administration (FDA) will soon begin reviewing at least one vaccine for emergency use authorization. However, even if a vaccine is ready for distribution as soon as next month, many state and local governments still lack the proper funding needed to distribute vaccines. According to a recent letter sent by the Association of State and Territorial Health Officials (ASTHO) and the Association of Immunization Managers (AIM) to congressional leaders, a minimum of \$8.4 billion is needed distribute COVID-19 vaccines nationwide. Some experts even estimated that \$10 billion is required in order to fund community vaccination clinics alone.

"For months, as states, territories, Indian Tribes, and other localities have been responding to COVID-19 and working tirelessly to keep their residents safe, they have also been preparing to undertake one of the largest vaccination efforts in our nation's history," the lawmakers wrote in a letter sent today to Senate Majority Leader Mitch McConnell (R-KY), Democratic Leader Chuck Schumer (D-NY), House Speaker Nancy Pelosi and House Minority Leader Kevin McCarthy. "To accomplish this, jurisdictions must recruit and train thousands of health care workers, modernize data systems and registries, stand up vaccination sites, develop communications and educational materials, and build and support the infrastructure needed to distribute multiple types and doses of COVID-19 vaccines, among other activities."

"To ensure that jurisdictions throughout the country are well-positioned to immediately, efficiently, and equitably distribute COVID-19 vaccines as they become available, we respectfully request that any upcoming legislation to address the pandemic include robust funding for COVID-19 vaccine distribution efforts," the lawmakers concluded.

When business entrepreneur Jamey Flannery official takes possession of Crandon International Raceway on New Year's Day, much than the ownership will change. In fact, the entire way the historic racetrack does business will undergo a massive transformation.

Since its inception in 1970, off-road racing in Crandon has operated as a not-for-profit club created to help support many local and regional charities. It has been a highly symbiotic relationship for both sides, offering the 400-plus acre facility access to much needed volunteer labor during world-class race weekends in exchange for year-end financial contributions to a wide variety of local charities. In fact, the largest purpose-built facility of its kind in the world has contributed millions of dollars in much needed support to the small city of Crandon and surrounding Forest County.

Jamey Flannery's vision for the future of Crandon International Raceway may be operationally different than the past, but his already well documented interest in helping locally based community programs will remain a cornerstone in moving forward.

"It's important to honor the service of so many people and organizations that contributed to this track by carrying things forward in the future," Flannery explained. "There will still be opportunity for volunteer organizations here at the track, and there always will be as far as I'm concerned."

At the recent 27th Forest County Potawatomi race weekend the track and Jamey Flannery Trucking combined forces to contribute two new drug K9s to the Forest County Sheriff's office. Flannery was also the driving force in kick-start the first annual "Crandon Rocks" concert with Kid Rock at the tracks 50th anniversary race in 2019. Racing at Crandon began under the umbrella of the original "Wolfheads Sportsmen Club" umbrella, also a non-profit entity. In 1984 the group moved into its present home on US Highway 8, eventually reforming under the official name of Crandon International Off-Road Raceway Association, Inc.

Following Wisconsin state law and the bylaws stated in official documents, the dissolution of a 501 (c) (3) organization requires that Crandon pay all outstanding accounts payable and other debt before distributing the remaining balance to a list of similar local organizations approved by the Forest County Circuit Court. The current intention by Crandon International's Board of Directors and President Cliff Flannery is that these contributions will be disbursed primarily in Crandon and the immediate surrounding area.

In keeping with a long-standing Crandon tradition (and COVID restrictions not withstanding), next February track management will organize and host its annual Volunteer Party. Held at the local town hall. It's a unique event to Crandon, a celebration that gathers more than 500 guests as an "official thank you" for their service to the track, with food, drinks, live music and a huge raffle for all to enjoy.

The evening also features the most important thing of all; the distribution of tens of thousands of dollars in financial support to worthy groups. While the overall structure of the track's operation will change on January 1, 2021, both Jamey Flannery and the outgoing members of Crandon's Board of Directors are united in a mindset that giving back to the community remains an important chapter to the overall story of Crandon International Raceway.

Currently the 28th annual Forest County Potawatomi Brush Run weekend is scheduled for June 25th - 27th, 2021 and the Polaris Crandon World Championships will take place September 3 - 5th, 2021. Season camping and grandstand reservations will go on sale for the 2021 season on New Years Day, January 1, 2021 by visiting www.crandonoffroad.com.
