AWSC Awards three as Snowmobile Friendly Communities

The Association of Wisconsin Snowmobile Clubs (AWSC) formally announces three Wisconsin Communities as a “Snowmobile Friendly Community.” Congratulations are in order for the Wisconsin communities of: Mountain, Forest County, and Waupaca County. These communities achieved their Snowmobile Friendly status by working with their local Snowmobile Club(s) to complete a 21-page application describing how their Community and local Snowmobile Clubs advocate for safe and responsible snowmobiling in their area. All SFC winners are awarded reflective, high-visibility, 24” x 36” highway signs to let all visitors know they are entering a “Snowmobile Friendly Community.”

The AWSC usually announces the Snowmobile Friendly Community Awards during their annual spring Convention, but COVID-19 has again forced a cancellation of this state-wide Snowmobile Convention for over 600 snowmobile clubs representing all 72 Wisconsin counties.

Wisconsin's unique Snowmobile Friendly Community Program was created through a partnership between the AWSC and the Wisconsin Department of Tourism. A statewide Evaluation Panel includes a Wisconsin Department of Tourism professional to ensure the Program accurately identifies which communities and snowmobile clubs are “best” at welcoming, preserving, and providing snowmobile access, support, and services for snowmobilers. The Snowmobile Friendly Community Award/Designation is a four-year designation and communities must reapply for subsequent awards.

The announcement and awarding of this year's Snowmobile Friendly Communities serves as the final major snowmobiling event of the season for the 612 Wisconsin Snowmobile Clubs who create and maintain over 24,000 miles of public snowmobile trails connecting all 72 Wisconsin counties.

Forest County snowmobile trails closed

All Forest County State funded snowmobile and ATV Trails will officially close as of Monday, March 8, 2021.

Forest County Ordinance prohibits the use of ATV/UTV’s on all State funded trails in Forest County during this closure.

The Nicolet State Trail and Wolf River State Trails will reopen for hiking, biking, horseback riding, dual sport cycles and ATV/UTV use on or around May 1, 2021.

As you’re reading this week’s article, I’ll be at the Wisconsin Water Week Convention, ‘virtually’. Wisconsin Water Week 2021, is a virtual interactive online event.

“The event is really of unprecedented scope in Wisconsin for bringing together professionals, government officials and the general public to learn and discuss water and water issues in our state,” said Mike Engleson, executive director of Wisconsin Lakes and Rivers Convention.

For more than 30 years the convention annually has been a gathering of water lovers of all stripes, including lake and river stewards and other leaders. Co-sponsors include the Wisconsin DNR, UW-Stevens Point and UW-Stout.

Speakers include climate scientist Katharine Hayhoe, former Wisconsin Gov. Tommy Thompson, and Marissa Jablonski, executive director of the Freshwater Collaborative of Wisconsin at UW-Milwaukee.

The first ever Wisconsin Water Week will feature 3 days of content-rich presentations and panels on Monday-Wednesday.

Monday will emphasize “Water Cycles,” including groundwater and climate, the two largest but mostly invisible pieces of our shared water inheritance.

Tuesday will explore “Water Bodies,” delving into the science of monitoring and managing lakes, rivers, wetlands, and watersheds, and evaluating their health. This includes the flora and fauna in and around these water bodies and how they interact.

Wednesday will focus on “Water Actions,” featuring examples and stories from the field that demonstrate how people and communities are tackling water challenges – even during these turbulent times.

COVID-19 vaccine update

The Forest County Health Department has been receiving weekly allocations from the State of Wisconsin of the Pfizer vaccine to aid in the response to the current pandemic. As of March 8th, 2021, 1,717,382 vaccines have been administered across the State of Wisconsin. In Forest County, 24.3% (2,186) of our residents have received at least one dose of the vaccine and 12.6% (1,138) have completed the vaccine series. There are currently three vaccines that have received EUA (Emergency Use Authorization) from the FDA for COVID-19; Pfizer, Moderna, and Johnson & Johnson. The Johnson & Johnson vaccine, also known as the Janssen vaccine, is the first one-dose vaccine in the U.S deemed safe and effective for the prevention of COVID-19. The vaccine has simpler storage requirements than the current vaccines. It can be kept in a refrigerator for up to three months, which allows the vaccine to be shipped directly to all areas of the state.

Similar to the Pfizer and Moderna vaccines, the Johnson & Johnson vaccine is highly effective at preventing infection. All three vaccines use different technologies to do the same thing - teach our bodies how to produce a harmless version of the coronavirus's spike protein, so our bodies can recognize it and produce an immune response to fight against illness if exposed.

“The Johnson & Johnson vaccine is held to the same high safety standards by the FDA as the other authorized COVID-19 vaccines. The trials show it is very effective at protecting people against being hospitalized or dying from COVID-19. We strongly encourage you to take whichever vaccine you are offered when it is your turn,” said DHS interim Secretary Karen Timberlake. “Vaccinations are some of the best tools we have to overcome this virus. And just one year ago, we would have been astonished and thrilled to know that we would have three effective and safe vaccines available to us.”

People can expect similar post-vaccination side effects with all the COVID-19 vaccines, such as feeling tired, fever, chills, headache, and pain and swelling in the arm where you got the shot.

The art and science of making maple syrup

You can always tell when spring has arrived and the maple sap is running. Brenda Davison wakes up her husband Pete after a long winter slumber and tells him to get busy. Friends arrive to help with the job of making 30 to 40 gallons of maple syrup on Pete's wooded property across the road from Lake Lucerne.

Looks can be deceiving! While this appears to be a motley crew, they are a well-oiled machine when it comes to gathering sap. Denny Abney does a good job of pushing the sled to the sap barrels. "Stick" Conway is slowly being trained to dip a pail in the sap barrel and pour it gently into the tray the sap is boiled in. Brian Schultz was caught doing the same job recently, but does well watching the bubbles rise in the boiling sap. Pete, the foreman of the crew, feeds wood into the fire after some coaxing by the rest of the guys or Brenda. He is getting quite accomplished at the task. The quality control guy is R.T. Krueger, who has expertise in water quality with his position at Northern Lake Service. He consumes some of the finished syrup. If he doesn't get sick, the rest of them will try it.

Sometimes, the gang gathers in the little shack near the sap boiler. With a nice fire in the wood stove, it is a great place to sample beer and other liquid condiments. This, of course, simply an exercise in determining which brand of beer or combination of booze and soda tastes best so they can make recommendations to their friends. It would be considered a public service by most aficionados of liquid condiments.

It is the rite of spring, as others from New England to Minnesota gather to put maple syrup in the family larder, and it continues a tradition that was started by Native Americans long before Europeans moved onto the continent. It is certainly a noble pursuit!

The man's name is lost to time, but at a glance it is easy to see that the company store of the Page & Landeck Lumber Company has been turned to Page Mercantile. That means that the lumber company was now Keith & Hiles, with Mr. Page running the store as his business. This is now the Subway in Crandon on the left of the building and Group Therapy on the right.

The brick building on the right of Page Mercantile was the Shaw building, but that was lost to fire early in the 20th century. The long gone Park Hotel is to the far right.

**New conditions VA presumes are related

Three new conditions were recently added to the list of presumptive conditions for which the Department of Veterans Affairs grants service connection to Vietnam War veterans affected by exposure to the chemical herbicide Agent Orange. This means that tens of thousands of veterans will now be eligible for VA disability benefits if their Agent Orange exposure resulted in bladder cancer, hypothyroidism, or Parkinson's Disease-like symptoms. The addition of these three conditions to VA's presumptive list will make it easier for veterans suffering from bladder cancer, hypothyroidism, or Parkinson's-like symptoms due to Agent Orange exposure to secure disability benefits from VA.

## THANK YOU!!

My name is Kayla Fraley, and I was diagnosed with Acute Myeloid Luekemia (AML) on December 22nd of 2020. I have under gone a long hospital stay with two rounds of chemotherapy, two bone marrow biopsies, and a PICC line insertion, that kept me in the hospital for 42 days. When my blood count numbers were normal, I was able to be released for a brief period. I was referred to Froedtert Hospital in Milwaukee to talk about a bone marrow transplant. At Froedtert Hospital I had my third bone marrow biopsy that later showed that I am in remission, and a bone marrow transplant talk will be down the road if necessary. On the 1st of March 2021, I was admitted back into the hospital to start my first round of consolidation chemotherapy, basically to keep me in remission without relapsing. I will have to go through four rounds of consolidation chemotherapy over the course of four months. I do get to come home after a week of consolidation to recover my blood count numbers, but I will be traveling for blood tests every other day.

From the very beginning of this scary fast journey, I have had the most amazing support from family, friends, and my community.

February 27th, 2021, my father teamed up with Jimmy and Dawn, owners of Pack Em Inn, and set up a last minute benefit for me. There were so many amazing donations from the community and local businesses to help raise money for medical bills, travel, and hotel stays. The donations were raffled off and it was a huge success. 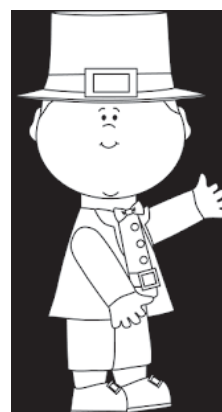

It was refreshing to see science work its way into the news recently. The writer of the 3/8/21 letter to the editor had his thinking cap on when he wondered if possible effects of the grand solar minimum that is just now beginning might mitigate some of the affects of human caused climate change. He referred to an internet article that suggested that might be the case, but the piece didn't quantify the extent of mitigation that might occur.

Other websites referred to NOAA data and charts, and agreed that the grand solar minimum could, indeed, reduce warming by a tenth of a degree or so, but noted that this small reduction would do little to mitigate the 2 to 4 degree increase expected from fossil fuel sources. It's interesting to recall that three decades ago Ronald Reagan and Margaret Thatcher worked quickly to address the "ozone hole" in the stratosphere that was caused by releases of certain types of Freon refrigerant gasses. The issue had become a science-proven major health and environmental concern. Those Reagan/Thatcher leadership efforts garnered worldwide support in just a few meetings of world leaders and led to those refrigerants being banned and replaced with safer ones.

It wasn't an inexpensive program, and came with some cost to society, but the issue was met head-on and quickly addressed. Today, most folks don't even recall the Montreal Protocol, but that atmospheric issue is well on its way to being solved and forgotten. It was a man-made dilemma that had planet-wide health consequences, but two politically conservative, yet science-respecting leaders got the job done with little delay and not much hoopla...a proud moment for worldwide problem solving.

A warming climate has far-reaching and significant ramifications for supporting life as we know it on our planet. Too bad for our grandkids that we seem to have dragged our feet addressing the issue.

## Senior Chatter

Make a List. Always keep an updated list of all the medications you take, the doses, and when they’re taken. Be sure to include any OTC drugs, vitamins, supplements, and herbal or other remedies. Keep a copy yourself and share the list and updates with all their doctors and caregivers. Take the list to all medical appointments and keep it on hand in case of emergencies.

Organize medications. Consider using a pill organizer, or ask the pharmacist for tips on keeping track of medications. If you have vision limitations, ask the pharmacist for large print labels on medication bottles.

Ask before taking over-the-counter medications. Always check with the doctor or pharmacist before taking any OTC drug, vitamin, or supplement because it could interact with prescription medications. OTC medications could also cause serious side effects in older adults or lead to accidental overdoses.


Review your medications. At least once or twice per year, ask your primary doctor to review the entire list of medications, supplements, and vitamins you take. Some may no longer be needed or the dose could be lowered, so ask if each one is still needed at the current dose. Often, if you’ve been hospitalized, there may be medications on the list for conditions that occurred in the hospital but are no longer present. The orders for drugs given in the hospital tend to carry over after discharge. You should ask whether these drugs are still needed because there is a strong tendency to continue anything prescribed at any time regardless of necessity going forward.

Ask questions. Unfortunately, our current state of drug pricing usually means the only question asked about medications is “how much will this cost me?” While paying for your medications is important, you should also ask the following questions:

- Whenever a new medication is prescribed or the dosage is changed, ask why.
- Check new medications for potential drug interactions with existing medications, especially if you are taking more than five medications.
- Ask about the purpose of the medication and how you will know if it’s working.
- Ask about what side effects to watch for.
- Ask when and how the medication should be taken.
- Ask about what to do if you miss a dose.
- Ask whether it can affect any other medical conditions you have.

Follow directions. Be sure to take medicines exactly as your doctor has prescribed. Make sure you understand how, when, and for how long the medication should be taken. Fill prescriptions at the same pharmacy so it has a record of all the medications that are being taken. Let the pharmacy know if there were any bad reactions so they can keep that on file.

Report problems. If you develop new health problems after starting a new medication, it may be a negative reaction. Tell the doctor immediately. If the reaction causes a serious issue, like difficulty breathing or swelling in the throat, call 911 and go to the emergency room right away.

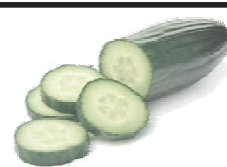

Baldwin Votes for Federal Funding to Help  
Wisconsin Small Businesses Stay Open and Reopen

WASHINGTON, D.C. – Today, the House of Representatives will vote on final passage of the American Rescue Plan and send it to President Biden to be signed into law. On Saturday, Senator Baldwin voted to pass the legislation in the Senate, with includes federal aid for Wisconsin small businesses, including restaurants.

“The COVID-19 pandemic has been devastating for Wisconsin small businesses and the American Rescue Plan provides help so they can stay open, keep workers on the payroll, and reopen completely when we get past this public health crisis,” said Senator Baldwin. “Wisconsin Congressional Republicans oppose the American Rescue Plan and have said it is unnecessary and that it’s a ‘bailout,’ but I know small businesses are the engine of our economy and they need help. The American Rescue Plan provides more, targeted federal funding and resources to the hardest-hit small businesses in Wisconsin, including restaurants. This support is targeted and necessary to move our Wisconsin economy forward.”

Senator Baldwin has consistently supported providing federal aid to help Wisconsin’s small businesses stay afloat during the pandemic. She worked to make sure the American Rescue Plan includes funding for independent restaurants and their workers, live entertainment venues, and has also supported reforms to improve the Paycheck Protection Program to reach underserved communities and the smallest, most vulnerable businesses.

The American Rescue Plan Act includes more funding and support for Wisconsin small businesses:

- Establishes a \$25 billion Restaurant Revitalization Fund, which will provide grants to help local restaurants keep their doors open and keep their workers employed.

- Allows businesses that received PPP loans in 2021 to be eligible for the Shuttered Venue Operator Grant Program.
- Establishes the Community Navigator pilot program to improve access to COVID-19 relief, especially for underserved communities.

new ads to help quit smoking

The Centers for Disease Control and Prevention's (CDC) Tips From Former Smokers® (Tips®) campaign is entering its 10th year with new ads that encourage people who smoke to quit. The Tips campaign is the nation's first federally funded tobacco education campaign and has helped more than 1 million U.S. adults to quit smoking and inspired millions more to try to quit.

The ads will run March 1 through September 26 on national cable and network television, streaming radio, and online. The latest Tips ads will continue to share personal stories of people suffering from smoking-related illnesses. In addition, new ads will tell the stories of family members who take care of a loved one suffering from a smoking-related disease. Caring for a loved one with a smoking-related illness can affect the caregiver's life in various ways, including their ability to work and maintain physical and mental health.

Research shows that emotionally evocative, evidence-based campaigns, like Tips, are effective in raising awareness about the dangers of smoking and helping people who smoke to quit. These campaigns are even more effective when coupled with the availability of quitlines, which provide free, confidential support services to help people quit smoking. Each year when the Tips campaign is aired, there is an immediate and marked spike in calls to 1-800-QUIT-NOW and visits to the campaign website.

“For nearly a decade, the Tips campaign has inspired millions of Americans to make the life-saving decision to try to quit smoking,” said Deirdre Lawrence Kittner, PhD, MPH, Director of CDC’s Office on Smoking and Health. “By courageously sharing deeply personal stories, the heroes in these new ads give a voice to the more than 16 million Americans living with a smoking-related disease.”

In 2011-2015 in Wisconsin, approximately 14% of all deaths were directly attributable to smoking. A recent study showed that from 2012-2018, the Tips campaign helped prevent an estimated 129,000 early deaths and helped save an estimated \$7.3 billion in smoking-related healthcare costs.

“CDC's Tips campaign is effective in bringing to life the harmful effects of smoking and connecting people with resources to help them quit,” said Jacee Shepard, Director of the Forest County Health Department “As a public health official, I know all too well the adverse effects of smoking on health. The Forest County Health Department is committed to helping Wisconsin residents understand the reality of smoking-related disease and death and to prevent these realities from happening to them.”

In addition to the harm it causes to peoples' lives, cigarette smoking also has a significant impact on the U.S. economy. ## Forest County Potawatomi Community Farm adds maple syrup production

The Forest County Potawatomi Community is expanding operations at their farm, Bodwéwadmi Ktëgan, to include maple syrup production thanks to a grant from the First Nations Development Institute.

The mission of the First Nations Development Institute is to strengthen American Indian economies to support healthy Native communities.

"We are extremely grateful for the support from the First Nations Development Institute," said farm manager Dave Cronauer. "This grant will allow us to continue to expand our offerings and provide healthy, locally grown food options for both the Tribe and the community at large."

Bodwéwadmi Ktëgan, is in the process of starting a maple sugar bush – which is a forest stand used for maple syrup. The sugar bush was scheduled to be completed for the 2021 sap flow, but due to pandemic constraints has been pushed back to the 2022 sap season.

Once completed, the sugar bush will allow the farm to expand its capacity to include the production of maple syrup and other maple value-added products, which have been a traditional food staple for the Potawatomi. The new process will allow the farm to tap 1000 sugar maples, pump the sap into holding containers, process the sap through a reverse osmosis machine, and complete the process in an evaporator. It will then be bottled or further processed into other maple products.

The project will increase the economic opportunity and self-sufficiency of the Forest County Potawatomi Community and its members by strengthening the local food system through the creation of a Maple Sugaring Operation. It will also serve as an educational tool for area youth and provide best practices to other tribes.

"We have seen tremendous growth and demand for our farm products by the tribal community and the general public over the over the last year," said Cronauer. "We are glad that we are able to provide healthy, locally grown food options for this community."

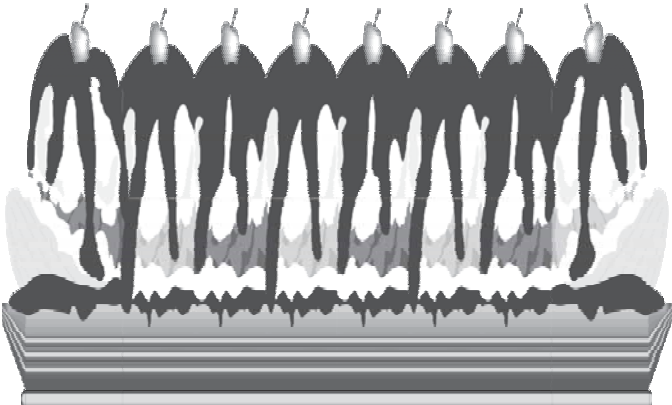

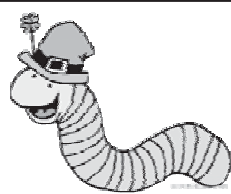

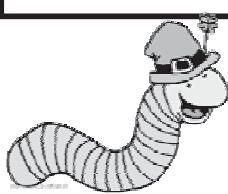
