## The Aquaponic Greehthouse

There is a new business venture in Armstrong Creek. Scott Goode has started and is running an aquaponic greenhouse.

It looks like a greenhouse, and it is, but the main function of this greenhouse is to raise fathead minnows for the fishing public to use as bait.

The fathead is a popular bait fish. Most, however, are raised and brought in from Minnesota. The idea is that raising them close to home saves transportation costs and gives the bait dealer, and hopefully Scott, more money for the popular bait fish.

Ths fish tanks are on the lower level, and hold about 3,000 gallons of water. The tank is sunk in the ground about four feet. The waste from the fish would accumulate in the tanks except that the water is pumped up to the greenhouse part of the operation where the plants pull out the nitrates and add growth. The water is dropped back into the tanks purified by the plants. About 1,000 gallons per hour is exchanged.

There is, as can be seen in the pictures, some healthy plants growing on the 2nd story shelves. There are tomato plants in bloom, carrots, peppers and more growing nicely. In addition to the bait fish, there will be fresh vegetables growing long after the normal season is over.

### Land Management Plans

#### Why do you need a land management plan?

They are the key to the successful management of your forest. Land management plans are long-term and provide continuity through generations of ownership. Make sure to go over your plan with family members that may be purchasing or inheriting the land in the future. If you don't already have a land management plan in place, make sure to talk with your natural resource professional to set up a free on-site walk-through of your property and begin the process of creating your personalized land management plan!

**Practice Plan:** This is written to cover a very specific action that will happen on your land. An example is a tree planting plan, which can include goals, map of the area, site preparation, what species to order and how many, and any cost-share assistance that could be applied for.

**Basic Plan:** This kind of plan will outline general management practices for a property. It may be in letter form or a summary of management activities. This is most often received from a natural resource professional after an initial conversation about your goals and a walk through of the property.

**Comprehensive Plan:** These are the most detailed plans that incorporate sustainable forestry principles. One example is a Forest Stewardship Plan, which has 16 natural resource elements that can be addressed. The needs of this plan can be agreed upon between the landowner and a natural resource professional after a property walk-through and conversations about land objectives. Another example requiring a comprehensive plan is the Wisconsin Managed Forest Law (MFL) Program. This is a landowner incentive program that offers reduced property taxes when following sound forest management. A MFL plan is needed for the MFL Program application and must be written by a DNR certified plan writer.

## 1,178 cases of covid-19 (66 active) confirmed in forest county

Forest County Public Health officials have confirmed 55 additional persons has been diagnosed with novel coronavirus infection (COVID-19) in the last week, for a total of 1,178 cases in Forest County. County health officials and local partners are contacting others with whom the individuals who tested positive had close contact with. As of Friday, September 17th, Forest County has 5,818 negative test results. There are currently 66 active cases in isolation, 1,083 released from isolation, 4 hospitalized, and 25 deaths related to COVID-19.

The Forest County Health Department encourages community members to practice good hand hygiene, wear a mask or cloth face covering when necessary, and stay alert for symptoms of COVID-19. If you are experiencing any symptoms or have been exposed to someone with COVID-19, please contact your health care provider and ask to be tested. If you are interested in a COVID-19 vaccine, please call our office or your primary care provider.

## Work on Vet's Park is progressing



The last of the topsoil is being spread through the center of the campground. The edges are done and seeded. As can be seen on the left of the photo, a ray of sunshine broke through the clouds as work went on.



The first to use the rejuvenated park are the sea gulls, as can be seen on the left side of this photo. They seem to like the freshly seeded areas. The park will be fully seeded this fall, and some areas, as the foreground of this photo are already coming up green. The water lines still need to be installed and should be in this fall. There are some electric pedestals still to be installed, and should be in place shortly.

While the grass should be healthy by next Memorial Day, the blacktop on the road around the park will likely be allowed to settle until sometime in June, when the park will try to reopen. Tree planting will take place the next year, when the fill dirt has been allowed to settle.



The edges of the park are green, and when the topsoil is done in the middle of the grounds and seeded, it too should be green before the autumn season is over.

### Turkey

The fall turkey season opens statewide on Sept. 18. Closing dates for the fall turkey season vary by management zone. In zones 1-5, the season closes Jan. 9, 2022. In zones 6 and 7, the season closes Nov. 19. The use of dogs to hunt wild turkey is allowed statewide for the fall seasons.

Overall, Wisconsin's statewide wild turkey population remains strong. Following 30 years of sustained population growth and expansion across the state, wild turkeys are now found statewide. Wild turkey numbers appear to have stabilized at levels suitable to available habitat and will likely ebb and flow around those levels in response to weather, food availability and other natural factors.

Biologists closely monitor harvest during the either-sex fall turkey hunting season, as excessive hen harvest can affect turkey populations. Recent hen harvests in Wisconsin have been very low, and current hen harvest rates do not play a significant role in Wisconsin's turkey flock dynamics.

"Last winter was relatively mild with low snow levels statewide and few long-lasting cold snaps," said Alaina Gerrits, DNR Marinette County Wildlife Biologist. "Mild winter conditions paired with an early spring green-up and dry weather point to favorable brooding conditions for 2021. All field reports suggest a healthy and robust turkey population providing many opportunities for fall hunting."

Turkey hunters must have a fall turkey license, fall turkey harvest authorization and annual Wild Turkey Stamp. Each fall turkey license or conservation patron license now includes a fall turkey harvest authorization. Hunters must choose the zone for which their harvest authorization will be valid at the time of purchase. If more than one fall turkey harvest authorization is desired, hunters may purchase bonus turkey harvest authorizations in select zones while inventory remains. Licenses, stamps and bonus turkey harvest authorizations are available online at Go Wild or any license agent.

During gun deer season, turkey hunters are reminded that ground blinds on DNR lands are subject to highly visible color requirements. All unoccupied ground blinds must have the owner's name and address or DNR customer ID number near the door opening. Blinds and elevated devices can be left overnight Sept. 1 to Jan. 31 on DNR-managed properties north of Highway 64. Blinds and elevated devices south of Highway 64 on DNR-managed lands may not be left out overnight and must be removed daily at the close of shooting hours. Blinds used for waterfowl hunting or constructed entirely of vegetation do not have to be removed daily.

## DNR season outlook for fall wild turkey, ruffed grouse and woodcock seasons



MADISON, Wis. – The Wisconsin Department of Natural Resources (DNR) announced the season outlook for ruffed grouse, woodcock and wild turkey, plus essential updates for hunters to be in the know.

The DNR provides hunters with free online mapping tools to identify habitat types and public land open to hunting upland game birds. The online Fields and Forest Lands Interactive Gamebird Hunting Tool provides upland gamebird hunters with an interactive way to locate cover suitable for ruffed grouse and woodcock, managed dove fields and properties stocked with game farm pheasants. On the go, hunters can use the DNR's free Hunt Wild Wisconsin mobile app.

### Ruffed Grouse

The ruffed grouse season is open in Zone A Sept. 18 - Jan. 9, 2022. This earlier closure than previous years follows the DNR's 10-year ruffed grouse management plan. In Zone B, the season is open Oct. 16 - Dec. 8.

Statewide drumming survey results indicated a decrease of 6% in breeding grouse compared to 2019. Surveys were not completed in 2020 due to the ongoing COVID-19 public health emergency. In Wisconsin, the 10-year ruffed grouse population cycle typically peaks in years that end in 0, 9 or 1. This likely indicates we are entering the typical "down-phase" of the 10-year cycle.

To help track West Nile virus impacts in ruffed grouse, hunters are encouraged to participate in the final year of the DNR's West Nile virus sampling project this fall. As a reminder to hunters who requested a kit, they are now available for pickup at the service station you indicated on the survey.

### Woodcock

Wisconsin's woodcock hunting season is open Sept. 25 - Nov. 8. Like waterfowl and mourning doves, woodcock are migratory game birds, so hunters who plan to pursue them must register annually with the Harvest Information Program (HIP).

### Forest Service waives day-use fees for National Public Lands Day

The U.S. Forest Service will waive fees at day-use recreation sites on Saturday, Sept. 25, in recognition of National Public Lands Day. This time of year on the Chequamegon-Nicolet National Forest, the fee waiver applies to beaches, boat launches, picnic areas and trailheads where visitors may normally pay a \$5 day-use fee.

National Public Lands Day is the nation's largest single-day volunteer effort for America's public lands. Local ranger district offices can provide information about group service opportunities or ideas for volunteering on the national forest.

"Public lands are available for us all to enjoy year-round," said Forest Supervisor Paul Strong. "Whether folks come out to volunteer or just to spend a day in nature, we encourage everyone to visit the national forest on Saturday."

Across the country, the fee waiver applies to many national forest picnic areas, boat launches, trailheads, and visitor centers. Fees for camping, cabin rentals, heritage expeditions or other permits still apply. Recreation sites operated by concessionaires will also continue to charge fees unless the individual manager chooses to participate in the holiday waiver.

Most days of the year, visitors to the Chequamegon-Nicolet National Forest must pay a day-use fee of \$5 per vehicle at most developed beaches, boat launches, picnic areas and trailheads. The forest provides envelopes for making on-site payments, or visitors may purchase an annual vehicle pass for \$30 through ranger district offices and local pass sale vendors.

Fourth grade students can get a free pass through the Every Kid Outdoors program. Veterans, Gold Star Family members, and active military personnel and their dependents are also eligible for free access to national forests. More information about national passes is available online at <https://go.usa.gov/xAz2m>.

The Forest Service manages 193 million acres of public lands and more than 3,000 world-class outdoor recreation areas, facilities and programs. Visitors may enjoy year-round, fee-free access to 98 percent of national forests and grasslands as well as two-thirds of developed recreation sites.

### Deer season is almost here: help slow the spread of CWD



The Wisconsin Department of Natural Resources (DNR) is asking deer hunters to join in the efforts to protect the state's deer herd, especially where chronic wasting disease (CWD) testing is most needed.

Wisconsin deer hunters play a crucial role in helping to control the spread of CWD. Each hunting season, hunters who have their deer tested for CWD, properly dispose of deer carcass waste and follow baiting and feeding regulations help the DNR monitor the disease and slow its spread.

While planning your hunt, be sure to check [baiting and feeding restrictions in your county](#). Even where baiting and feeding are allowed, the DNR encourages hunters to reconsider using these practices to reduce the risk for disease transmission, which can spread through body fluids like feces, saliva, blood and urine. Large concentrations of animals in one area increase the risk of an infection spreading from between them.

CWD is a contagious neurological disease of deer, elk, moose and reindeer (caribou) caused by misshapen proteins that slowly degrade the central nervous system. The disease is always fatal and can have an incubation period of over a year, so infected deer can appear healthy for many months before showing clinical signs. In the clinical stage, CWD causes drastic weight loss, drooping of the head and ears, loss of coordination, excessive salivation and no fear of humans.

CWD is also referred to as "transmissible spongiform encephalopathy" or prion disease. The disease triggers normal proteins in a deer's brain to fold abnormally, causing holes to form.

By having their deer tested, hunters provide the raw data needed to understand where CWD exists or doesn't exist on the landscape. As part of an ongoing multi-year statewide sweep, the DNR especially encourages hunters in 17 counties of northeast Wisconsin to have their adult deer tested this year. In addition to the northeast part of the state, the department monitors several additional sampling areas where samples are needed. No matter where you hunt in the state, all hunters can have their deer tested for CWD.

There is a form in each hunter's Go Wild harvest history to assist hunters with getting their deer tested for CWD after registering their harvest. The form automatically fills in name, contact information, customer ID number and harvest registration number. This online form also makes it easier to find the location the deer was harvested through an interactive map that allows the hunter to tap on the harvest location rather than writing out the county, town, range and section on the paper form.

The DNR offers [four easy ways to submit a sample](#):

Self-service kiosks where hunters can submit their deer's head for testing

A network of cooperating meat processors, taxidermists and other businesses who can assist with CWD sampling

By-appointment sampling with your county wildlife biologist and

Kits for hunters to extract lymph node tissue themselves to submit to the DNR for testing

Once hunters have finished processing their harvested deer, they can safely dispose of deer carcass waste [in designated deer carcass dumpsters](#) provided in conjunction with many partnering individuals and organizations around the state. Proper carcass disposal helps slow the spread of CWD by removing potentially infected deer carcasses from the landscape.

CWD testing, proper carcass disposal and following baiting and feeding regulations are three key ways to slow the spread. The DNR's [guide to slowing the spread of CWD](#) provides even more ways hunters can help.

While there has not been a documented case of CWD in humans, the Wisconsin Department of Health Services (DHS), the Centers for Disease Control and World Health Organization recommend against consuming meat from CWD-infected deer. Because infected deer can look healthy, DHS encourages testing for the disease regardless of your harvested deer's physical condition.

## Public input sought on WIS 32 project in Forest County

The Wisconsin Department of Transportation (WisDOT) is seeking public input on proposed improvements to WIS 32 between County C and Forest Avenue in the town of Wabeno, Forest County. Construction is currently scheduled for 2024.

**Proposed improvements include:**  
Removing and replacing pavement  
Replacing all curb and gutter in the project limits  
Upgrading curb ramps to meet Americans with Disabilities Act (ADA) standards  
Adding sidewalk between Fairview Avenue and Jones Avenue (north)  
Replacing sidewalk from River Street to County C (south) including a short extension to County C  
Storm sewer repairs including culvert replacement near Forest Avenue and ditch cleaning near County C  
Replacing a retaining wall near Jones Avenue  
Narrowing the roadway to a standard 36-foot width between curbs at select locations.  
Parking is proposed to remain between Jones Avenue and Elm Avenue (south) and west of Forest Avenue to Fairview Avenue (both sides)

**Traffic impacts:**  
During construction, WIS 32 will remain open. Motorists can expect to encounter lane shifts and flagging operations with reduced lane widths. Temporary driveway closures will be necessary during construction when work is occurring directly in front of the driveway.

**Real Estate:**  
Additional right of way will be required to accommodate curb ramp and sidewalk replacements, storm sewer repairs, and slope work. Coordination is ongoing with the owners of the following recreational lands; the ball diamond owned by the school district of Wabeno, the logging museum and bandshell near Cecil Avenue owned by the town of Wabeno, and the Nicolet State Trail owned by the Wisconsin Department of Natural Resources. All recreational facilities will be open during construction, but some temporary easements may be required. The project team is seeking public input related to the potential temporary use of these recreational lands along with other project input. Landowner rights information is available on the project website.

DHS does not give any member additional FoodShare benefits or cash rewards for doing something like completing a survey. FoodShare benefit amounts will only change when there is new information that affects a household's eligibility, or when there is a federal increase based on emergencies like the COVID-19 pandemic.

Sometimes organizations or agencies outside of DHS conduct surveys that may include a cash reward. However, always look more into any survey before completing it, so that you can make sure it is safe to complete.


