## Positive cases of covid-19 in Forest County

Forest County Public Health officials have confirmed 2 individuals have been diagnosed with novel coronavirus infection (COVID-19) since March 1, 2022 with either a PCR, antigen, or home test. County health officials and local partners are contacting individuals who test positive as able. There have been 6 deaths this year related to COVID-19. This is a snapshot of the numbers as they are continuously changing throughout the day.

The Forest County Health Department encourages community members to get vaccinated, practice good hand hygiene, wear a mask or cloth face covering when necessary, and stay alert for symptoms of COVID-19. If you are experiencing any symptoms or have been exposed to someone with COVID-19, please contact your health care provider and ask to be tested. If positive, please isolate yourself away from others for 5 days since symptom onset and wear a mask for the 5 days following your release from isolation.

Last week you may have seen fliers, heard radio announcements, or seen tv announcements about the Internet Speed Tests being done across the State. As many of you know. Internet Connections across the Northwoods may not be the best.

All of us should have access to broadband for work, school, safety, health and play. But many homes and businesses in Wisconsin have slow or no internet access.

Together we can fix that.

The first step is to identify and document the areas with no broadband or limited access to it. That's where you come in.

- We need as many Wisconsin residents as possible to take a simple internet speed test.
- ·From your home or business, simply visit expressoptimizer.net/public/. If you're using your phone, it's important to make sure you do the test from your internet connection and not your cellular connection.
- •It will only take a few moments and your personal information is always protected and will never be shared.
- Even if your home doesn't have reliable internet access, you can help.

Visit expressoptimizer.net/public/ from a friend's home or the local library and click on "Enter an address with No Available Service" to complete the survey.

With this information, we can access grant funding designated to bring broadband to the areas of our state that need it.

Once the test is completed, my office can draw the maps and locate areas with little or no internet connectivity and focus the grant funds on these areas in our county.

# Townsend Town Hall building proposal **Open Meeting April 12**



In 2018, the Townsend Town Board put together a group of citizens to begin the process of replacing the existing town hall with a new building. #### **DNR Spring Hearings/Conservation Congress County Meetings April 11**

Wisconsin residents can express support or nonsupport for an array of resource management issues through the virtual DNR Spring Hearings and Conservation Congress' Annual County Meetings beginning Monday, April 11 starting at 7 p.m. The opportunity will be available for 72 hours.

The questions can be previewed on the Spring Hearing website (dnr.wi.gov search "spring hearings"). The link to the survey will also be posted on this same webpage by April 11.

The county meetings are held jointly with the Department of Natural Resources Spring Hearings. The Wisconsin Conservation Congress is a statutorily established advisory group to the state Natural Resources Board (NRB).

Results of the public's input on these proposals will be presented to the Natural Resources Board in May 2022. If there is support for a proposal, the advisory question could become a DNR rule change proposal in

This year the Conservation Congress will seek public input on 45 advisory questions on a range of topics, some of which include:

- a proposal to extend the 9-day gun deer registration deadline;
- a proposal to remove the Burbot from the list of Wisconsin Rough Fish;
- a proposal to require canoe and kayak registration;

"Conservation Congress advisory questions generally originate from citizens' ideas." said Tony Blattler, Chair of the Wisconsin Conservation Congress. "If resolutions presented at the county level are supported, the resolution is advanced to one of the Congress' advisory committees and the District Leadership Council for consideration."

"Last year, there were over 400 resolutions submitted. Not all resolutions pass, but the ones that do have the potential to become a rule, policy or legislative change in the subsequent years," Blatter said. "It is a true grassroots process that empowers the citizens of this state to shape natural resources policy."

There was no date on the picture, but judging by the sign for Wabikon Lake Resort, it is obvious that the truck has just pulled out on what is now U.S. 8 just west of Laona. It is also a good bet that the logs are white pine, as few hardwoods get that big. The tires on the truck would also be flattened because of the weight of hardwood versus pine.

The Wabikon Lake sign can only denote the current resort and bar run by Musky John today. It is nice to know you could get beer there back then, and you still can today. On the bottom of the sign it says "See Gene." Not sure who he was, but we will likely find out. The year the photo was taken isn't known, but it was before Hwy 8 was blacktopped, and judging from the cars, it was likely in the 1930's.

## Nicolet College shines light on March as National Disability Awareness Month

College is challenging for just about everybody.

Now imagine taking on those challenges when you have a disability.

"People are really surprised when they find out how many students on college campuses are performing at a high level and succeeding in college despite having a disability," said Kaye Mathwich, Nicolet College accommodations specialist.

"There's a whole population of students who are managing quite well and not letting their disability stop them from reaching their goals in life."

At Nicolet, about one in 10 students over the past three years has identified as having any one or more of a multitude of recognized disabilities. The total number of students with disabilities include 175 in 2019, 146 in 2020, and 125 in 2021.

With March being National Disability Awareness Month, Mathwich said it's important to shine a light on the many services and accommodations Nicolet offers that pave the way for individuals with disabilities to be successful in college.

In any given year she said about 120 individuals come to her to discuss their disability and then receive the appropriate accommodations. The others prefer not to have an accommodation for various reasons.

Common conditions include learning disabilities including reading processing disorders such as dyslexia, psychological conditions such as anxiety, depression, and PTSD, ADD/ADHD, mobility and orthopedic issues, Autism Spectrum Disorder, vision and hearing disabilities, and chronic health conditions.

Mathwich meets with every individual one-on-one to first understand their disability and then lay out a plan and secure any resources they may need.

Common accommodations include adaptive equipment, textbooks in audio format, testing accommodations, large-print materials, note-taking assistance, sign language interpreters, and assistive technology.

One student at Nicolet who Mathwich has worked with is Emily, who preferred not to have her real name used, who has dyslexia and requested to have extra time during tests.

"That little simple thing has been a huge help for me, because I don't read as fast as others do," said Emily, who is in her second year in the University Transfer Liberal Arts program and carrying a B average. "That accommodation has really helped me be successful at Nicolet."

After Nicolet she plans to transfer to a four-year campus to earn her bachelor's degree in phycology.

Nicolet, in partnership with Headwaters, Inc., also offers a Jump! Start program for adult learners with intellectual disabilities. This program creates opportunities for college experiences, education, employment preparation, and peer interaction.

Other partner organizations include area high schools, state and local organizations, and advocacy groups that support people with disabilities of all ages.

Jump! Start provides students the opportunity to learn skills on how to live more independently in the community, employment skills training and job shadow and internship opportunities, access to college coursework, and goal setting skills.

"Nicolet cares about all students no matter where they are in life," Mathwich explained. "We want all students to succeed."



- Prevent weight gain.



#### Trail closures on the Chequamegon-Nicolet National Forest

Rhinelander, WI - March 29, 2022 - Snowmobile, all-terrain vehicle (ATV), utility-terrain vehicle (UTV), horse, and bicycle trails are closed due to spring break-up.

Every spring, the use of wheeled motorized vehicles, mountain bikes, horses or other pack or saddle animals is prohibited on National Forest System trails until May 1.

"Due to snowmelt and spring rains, the ground and trails become very saturated. We ask that the public refrain from using off-highway vehicles, bikes, and horses at this time," said Katie Lemoine, West zone assistant recreation program manager. "As we get closer to May, Forest Service staff will continue to evaluate trail conditions and open trails as it is safe to do so."

The re-opening of trails on May 1 is dependent on trail conditions. Seasonal closure reduces rutting and erosion of trails which often occurs when the soil is saturated. Protecting recreation trails during this time reduces the likelihood of repairs and future trail closures during the high use season.

ATV/UTV routes and other trails designated by towns under state law are not affected by this closure. Trail users should check local regulations for trails they plan to

Hiking trails remain open during spring break-up. If you plan to visit, ensure you are dressed properly for the weather including waterproof footwear. Let someone know where you are hiking and when you plan to return.


