Last weekend at a Saturday morning football game, my grandson asked me why leaves change color? I think I get asked this question every fall.

So, why do autumn leaves change their color?

It all starts with photosynthesis. Leaves typically produce their vivid hues of green from spring through summer into early fall through the constant creation of chlorophyll. As we all learned in grade school science, chlorophyll is the key component in a plant's ability to turn sunlight into glucose, which in turn feeds the trees. In spring and summer, millions of these chlorophyll cells saturate the leaves, ultimately making them appear green to the eye. Without the presence of chlorophyll in the leaf, the bright golds, reds, yellows, and browns would be the natural colors seen year-round.

Chlorophyll isn't the only thing involved in leaves changing color, however. Present in other leaves and trees are the compounds known as carotenoids andanthocyanins. As the Fall days begin to get shorter and shorter, the production of chlorophyll slows to a halt, eventually giving way to the 'true' color of the leaf. Flavonols are always present in leaves and give them the yellow color when chlorophyll production slows down in the fall. Beta-carotene is the most common carotenoid present in most leaves. It absorbs blue and green light, and reflects yellow and red light from the sun and gives leaves their orange hue when chlorophyll production drops. In the fall anthocyanin production increases. This compound protects the leaf through the fall and gives leaves their red color.

### Positive cases of covid-19 in Forest County

Forest County Public Health officials have confirmed 25 individuals have been diagnosed with novel coronavirus infection (COVID-19) since October 1, 2022 with either a PCR, antigen, or home test. County health officials and local partners are contacting individuals who test positive as able. There have been 7 deaths this year related to COVID-19. This is a snapshot of the numbers as they are continuously changing throughout the day.

The Forest County Health Department encourages community members to get vaccinated, practice good hand hygiene, wear a mask or cloth face covering when necessary, and stay alert for symptoms of COVID-19. If you are experiencing any symptoms or have been exposed to someone with COVID-19, please contact your health care provider and ask to be tested. If positive, please isolate yourself away from others for 5 days since symptom onset and wear a mask for the 5 days following your release from isolation.

In an effort to keep our community members upto-date on COVID-19, the Forest County Health Department will continue to update our Facebook page and local newspapers every 15<sup>th</sup> and 30<sup>th</sup> of each month with current COVID-19 case counts as capacity allows. One of the primary cornerstones in Crandon International Raceway's 53-year success story is making sure it continues to produce great shows for its legions of faithful fans and world-class racers. Founded by Jason Robinett, MidAmerica Outdoors' portfolio not only includes the Ultra4 USA series, but also America's premiere riding and racing off-road park spanning over 1,600 acres located in Jay, Oklahoma. Featuring a wide variety of spectator-friendly race areas, exciting terrain for trail riding and world-class amenities and facilities, the park plays host to multiple off-road racing circuits throughout the year.

"This new agreement is a direct result of Crandon not only opening its doors to Ultra4-style racing at the largest short-course event in the world, but also successfully blending two distinctive forms of off-road racing into one massive lifestyle festival weekend," explained Robinett. P Argonne The 8.7 percent cost-of-living adjustment (COLA) will begin with benefits payable to more than 65 million Social Security beneficiaries in January 2023. Increased payments to more than 7 million SSI beneficiaries will begin on December 30, 2022. (Note: some people receive both Social Security and SSI benefits). The Social Security Act ties the annual COLA to the increase in the Consumer Price Index as determined by the Department of Labor's Bureau of Labor Statistics.

"Medicare premiums are going down and Social Security benefits are going up in 2023, which will give seniors more peace of mind and breathing room. This year's substantial Social Security cost-of-living adjustment is the first time in over a decade that Medicare premiums are not rising and shows that we can provide more support to older Americans who count on the benefits they have earned," Acting Commissioner Kilolo Kijakazi said.

Some other adjustments that take effect in January of each year are based on the increase in average wages. Based on that increase, the maximum amount of earnings subject to the Social Security tax (taxable maximum) will increase to \$160,200 from \$147,000.

Social Security and SSI beneficiaries are normally notified by mail starting in early December about their new benefit amount. The fastest way to find out their new benefit amount is to access their personal my Social Security account to view the COLA notice online. It's secure, easy, and people find out before the mail arrives. People can also opt to receive a text or email alert when there is a new message from Social Security – such as their COLA notice – waiting for them, rather than receiving a letter in the mail. People may create or access their my Social Security account online at www.ssa.gov/myaccount.

Information about Medicare changes for 2023 is available at www.medicare.gov. For Social Security beneficiaries enrolled in Medicare, their new higher 2023 benefit amount will be available in December through the mailed COLA notice and my Social Security's Message Center.

#### Statewide Moratorium begins Tuesday, November 1, 2022

MADISON – The Public Service Commission of Wisconsin (PSC) is encouraging electric, natural gas, and water utility customers with outstanding bills to make payment arrangements with their provider or apply for financial assistance before the annual winter heating moratorium on disconnections begins. Every year, from November 1st to April 15th, utilities are prohibited from disconnecting customers' utility service for nonpayment when that service is used for home heating.

Although Wisconsin state law prohibits utilities from disconnecting essential services to residential customers during the moratorium period, customers currently disconnected must make arrangements to restore service. Utilities are not required to reconnect service until payment arrangements have been made. To make a payment or arrange a payment plan, customers should first contact their utility provider.

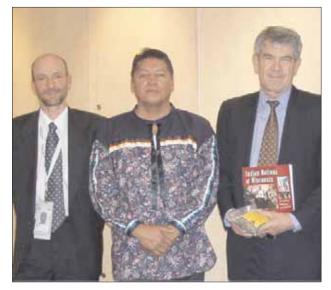

Folks,

I am sorry I wasn't able to attend the funeral services for Ken Van Zile today. But I want to share my condolences and sense of loss by sending this photograph as a tribute to his courage and leadership along with countless others in the Mole Lake Community to stop the Crandon Mine.

Ken Van Zile and Robert Van Zile made a long arduous trip to Johannesburg to have a direct discussion with the largest and most powerful mining company in the world and the owner of Nicolet Minerals ( aka the Crandon Mining Company).

This is an historic photo of Robert and Ken after our meeting with BHPBilliton officials in Johannesburg 20 years ago. Robert performed a pipe ceremony ( the CEO had to withdraw the no smoking ban in the Boardroom) Roman and I gave a power point while Robert spoke and Ken gave Brian Gilbertson (CEO of BHP)some wild rice. He is holding Patti Loew's book on Wisconsin Natives that I gave him after Robert's presentation when he told the BHP executives that there would be a never ending battle to stop the Proposed Crandon Mine.

At the end of our meeting, Mr. Gilbertson told us that they were going to meet with their counterparts in Houston to discuss the Crandon project. Two weeks later, they closed the Crandon office. One year later, Mole Lake bought The Nicolet Minerals Company with an 8 million dollar IOU to BHPBilliton. Two years after that BHP essentially forgave the debt and returned the funds to Mole Lake in a trust fund.

This moment was the beginning of the end.

After our meeting, Roman and I suggested that we rent a car and go to a game reserve to see some lions and elephants. But both Ken and Robert changed their tickets to go home two days early because it was ricing season. Ken was also a little worried that the South African lions might like the taste of a North American Ojibwe! When they both got home both Robert and Ken felt like the richest people on the Planet after seeing the misery of the mining world in Johannesburg.

Please extend my sympathies and condolences to Ken's family and the Community. He was an Eco Warrior and a hero to his community and The Nation. I Was proud to have known him and worked with him.

cell creation is complete, water and nutrients no longer flow to and from the leaf. The leaf will die and weaken at the stem, eventually falling to the ground.

What happens to the leaves?

Mother Nature is fantastic at recycling. Whether through the water cycle, or the slow process of decomposing plants and trees back in to soil, the Earth wastes very little. When leaves fall to the ground, they begin to break down and eventually create a rich humus on the forest floor that absorbs dew and rainfall. This nutrient-rich 'sponge' acts as a continual source of nutrients and water for trees and plants, helping to promote life and plant health in the next spring season.

It is not difficult to conclude that while the falling of the leaves protects the trees through winter, it's likely that trees would not survive as well without the rich layer of dead leaves through the warm spring and summer months. In this way, trees' natural cycle provides health and sustainability for itself year after year.

Hunting mentors needed MADISON, Wis. – The Wisconsin Department of Natural Resources (DNR) is encouraging experienced hunters to share their skills and knowledge with novice hunters by becoming hunting mentors this fall.

Mentored hunting is a one-on-one learning experience that can be a great way to help new hunters navigate hunting scenarios with the guidance of somebody with experience.

"Not only do we see interest in learning to hunt from people of all different backgrounds, but many established hunters ask us how to mentor someone new," said Emily Iehl, DNR Hunting & Shooting Sports Program Specialist. "Hunting involves skills that can be uncomfortable to teach and learn with someone you don't know, such as navigating the woods at night, handling firearms and processing the emotions that come with harvesting an animal. Knowing that you are with somebody you can trust is important."

The DNR offers a variety of opportunities to help facilitate mentored hunting for people of all ages and backgrounds:

#### **Mentored Hunting Program**

This one-on-one mentoring opportunity gives novice hunters a chance to try hunting without first completing a Hunter Safety course. No special steps are required to purchase a mentored hunting license - log in to GoWild to buy a hunting license and any necessary stamps. If the account does not have a valid Hunter Safety Certificate on record, the license will automatically print as "Mentored Only."

Anyone hunting with a Mentored Only license must stay within arm's reach of a licensed hunter (mentor) over age 18, must have all required hunting approvals for the applicable season (license, permit, tag, etc.), and must comply with all other hunting laws, including season, bag limit and weapon regulations. Under the Mentored Hunting Law, mentors may have any valid, non-expired Wisconsin hunting approval, regardless of the type of game pursued by the mentee. Learn more here. Learn To Hunt

Learn to Hunt programs combine four-plus hours of classroom and field instruction before a novice goes hunting one-on-one with a qualified mentor. Local organizations typically host Learn to Hunt programs for a group of novice participants, for whom they may request waivers for some hunting regulations to help facilitate mentorship and remove barriers to teaching and learning. Learn to Hunt mentors must be at least 18 years old, have five years of hunting experience for the Learn to Hunt program species and complete the Mentor Background Check Authorization. Mentor background checks must be completed every five years. To learn more about hosting a Learn to Hunt program or to sign up as a student, visit the Learn to Hunt webpage.

Hunters must hold the required valid licenses, stamps and permits/harvest authorizations for the species they wish to pursue. An adult 18 years of age or older must accompany the youth hunter. An adult cannot accompany more than two youth hunters at one time.

#### **Become An Instructor**

Volunteer instructors are key to having successful education programs. Becoming a volunteer Hunter Education or Learn to Hunt instructor is a great way to help save lives, prevent injuries, meet people in your community and positively influence the attitudes and actions of other outdoor recreationists.

In these programs, students learn about safe gun handling, marksmanship, game care and the environment.

Volunteer Hunter Education Instructors must be at least 18 years old, graduate from the Hunter Safety student course in Wisconsin, be willing to devote the necessary time and effort to carry out program responsibilities and pass a background check. Learn more here.
