Fifty-seven cases Of Covid-19 confirmed in Forest County

Forest County Public Health officials have confirmed additional persons have been diagnosed with novel coronavirus infection (COVID-19) for a total of 57 cases in Forest County. The individuals are isolating at home. No further information will be released to protect the confidentiality of the individuals. County health officials and local partners are contacting others with whom the individuals who tested positive had close contact with. As of today, Forest County has 1,382 negative test results and 11 pending. There are currently 7 active cases, 46 recovered, and 4 deaths.

The Forest County Health Department encourages community members to minimize their contact with others by staying home when possible, practice physical distancing and good personal hygiene, wear a mask or cloth face covering, and stay alert for symptoms of COVID-19. If you are experiencing any symptoms or have been exposed to someone with COVID-19, please contact your health care provider and ask to be tested.

In an effort to keep our community members up to date on COVID-19, the Forest County Health Department will continue to update our Facebook page daily and local newspapers weekly with current COVID-19 case counts. This will include the number of negative and positive cases in Forest County. Please call our office at 715-478-3371 with any questions or concerns.

Conservation Corner

Next week, Conservationists across the State will be participating in a Roadside Blitz. We will be out traveling our respective county roads looking for terrestrial invasive species. As I've been traveling, I want to say we are lucky to be in a state with great native wildflowers.

I would like to point out some of the wildflowers you can see on the roadsides and in the woods. We start out with our State Flower- The Wood Violet. The wood violet is a pretty small plant only reaching about 6 inches tall. These beauties can be seen with a variety of colors from purple, blue and white.

Wild Lupine- This plant blooms profusely in spikes with pea-like blue and purple flowers. Palm-shaped leaves surround it, adding extra attraction. This legume is essential to the life cycle of the Karner Blue butterfly, a federally-endangered species native to the Great Lakes region.

Another beauty that are gone for the season is the Trillium- A beautiful white flower, with three large pedals alternating with three green leaves. They are always a sure sign spring has arrived in our woods!

Blood Root- These flowers have long pedals (between 6-8) and are bright white. When they grow, they grow wrapped up in their leaves and are short in stature. Blood root grow from rhizomes in the ground, which rhizomes have poisonous sap in them, thus giving the plant its famous name. These don't bloom for long; the petals start to fall after about a week.

Another early spring flower is the Spring Beauty. They are another long pedaled flower. A little more delicate than the Blood Root, it has a dull white and pink color. Spring Beauties form one central stem and branch out to even smaller stems containing the blooming flower at the end, creating big patches.

Jack in the Pulpit- A hardy, unique woodland flower that emerges and forms a unique cylindrical "pulpit" over which grows a single-leaf canopy. From the pulpit emerges little preaching "Jack."

With mid-summer here, a lot of us are starting to see Milkweed. This tall growing flower is vital for butterfly habitat and food source.

We will also be seeing Wild Bergamot, a plant that resembles a purple firework. They stand about 2-4 ft tall. Looks beautiful in prairie fields.

Something else to watch out for... The Orange Day Lily. These orange blooms might look pretty, but they are actually an invasive species. These have 6 pedals and NO spots (similar to the Wood Lily.)

Safe practices for Forest County residents

To prevent getting and spreading COVID-19, make sure you practice good personal health habits and avoid being exposed to the virus.

Avoid close contact with others and practice physical distancing. Stay home if you don't feel well. If you have symptoms, call your local provider and make an appointment to be tested, do not be around other people until your test results are in. Work from home when possible, have virtual gatherings and use curbside pickup or delivery for food or groceries. Wear a cloth face covering in situations when physical distancing is difficult. If you are gathering with other people, practice social distancing. Do not share food or drinks with other people. Wash your hands frequently and avoid touching shared surfaces.

If you choose to be in a high risk situation and are named as a close contact of someone who has tested positive, you will be asked by the health department to quarantine for 14 days from date of exposure. Close contact is having contact with someone for 15 minutes or more, or being in a place that was identified as having positive cases in attendance. An example of this would be attending a large gathering where food and drinks are being shared and it is difficult to remain 6 feet apart, and people are traveling from outside the area to attend. The longer the interaction lasts the higher the risk of becoming infected and spreading CoVid-19.

Symptoms of CoVid-19 vary among people from none to shortness of breath, coughing, fever, chills, loss of taste and smell, sore throat, body aches, headaches, congestion, runny nose, nausea, vomiting and diarrhea. If you feel you have been exposed, stay home, and monitor for symptoms, if you develop symptoms, get tested.

Together we can keep our community safe. We commend you for doing what you can to help stop the spread of CoVid-19. If you have any questions, call the Forest County Health Department at 715-478-3371.

Sharpen your shooting skills at area gun ranges

Entertainment can be a problem these days. Those who don't want to be in a crowd for a social event aren't attending the few that are still available. The walls can feel like they are closing in!

The hunting seasons aren't that far off. It might be a good idea to sharpen your shotgun skills and join in a little B.S. to resharpen your social skills!

Even if you have never shot the game of Trap, it is easy to get into it. One thing about a trap range is that there is no shortage of advice for newcomers and old hands alike!

The Padus Trap Range is open on Tuesday evenings, and they always welcome new faces. It is a relatively inexpensive sport. I should qualify that. Those who really get hooked on it do spend a few bucks, but it isn't necessary to have a good time. If you shoot poorly, don't worry, you will have plenty of company. Most trap shooters admit that they are usually competing with themselves and their past scores. A cheap gun will work, and so will cheap shells. Clay targets break easily. A round of trap is 25 shots from five different stations. It is a fun and easy to social distance, as there is a lot of room on a trap range. Padus is just off Hwy 32 on Padus Road, between Laona and Wabeno.

Another place to sharpen your skills is Heritage Hunt Club, at the Camp 5 Museum Complex on Laona's west side. This is a game called sporting clays, and it consists of 50 targets from ten different spots around the course. Unlike trap where all the targets are fanned out in front of you, sporting clays gives you targets that might cross in front, come directly at you overhead, go straight up in the air or even one station where they roll on the ground. Open bored shotguns of any gauge work best. Call ahead, they have an ad in this paper, and get familiar with a shooting game that definitely sharpen your hunting shooting skills.

So, dig out a shotgun and have some fun with it.



Do I want to get sick? No. But if it happens, I'll deal with it the best I can.


My life is in God's hands. You can disagree with me on that point if you want but I have peace even in the midst of this pandemic.







Driver licenses & IDs are most common forms of ID to show at the polls

Wisconsin driver licenses or IDs are the most common forms of identification used for voting purposes. Wisconsin Department of Transportation Division of Motor Vehicles (DMV) encourages voters to check and be sure that they have the proper identification needed to vote in the Partisan Primary August 11, 2020.

The Wisconsin Elections Commission notes there are other forms of identification that are valid for voting purposes, such as military or student ID cards. A federally-compliant REAL ID card, with a star in the upper right corner, is not required for voting purposes. There is no separate "voter ID." To see if a card meets the requirements, visit the Wisconsin Elections Commission website, bringit.wi.gov.

Voters looking to get their first Wisconsin ID can turn to DMV for help. To obtain an official state ID card, certain documents, such as a birth certificate, are required. If all documentation is not readily available, the ID Petition Process (IDPP) can be used to obtain a receipt valid for voting while the remaining documents or verifications are obtained. DMV offers this service and ID cards for voting purposes free of charge. DMV's toll-free Voter ID hotline at (844) 588-1069 is available for questions on obtaining an ID to vote.

"Our shipbuilding industry and its skilled workers have helped sustain America's security for generations, boasting a successful history of building ships for our nation's defense," said Senator Baldwin. "A new U.S. Navy submarine bearing the Wisconsin name will honor both our proud shipbuilding tradition and the men and women of our state who have worked hard to support this new class of ships."

"From the two dozen submarines built in Wisconsin during World War II to the thousands of Wisconsinites actively serving, naming a new Virginia-class submarine after our state would be a fitting tribute to Wisconsin's proud and deep naval history," said Senator Johnson.

The State of Wisconsin is known for producing key naval capabilities. In the 1940's, the city of Manitowoc produced 28 diesel powered submarines—25 of which deployed during WWII. Most recently, workers in Marinette have completed 10 Littoral Combat Ships for the U.S. Navy, with another 6 ships under construction, and the Marinette shipyard was recently awarded the contract for the Navy's new frigate program. This legacy of shipbuilding in Wisconsin is a testament to the strong ties between the state and the US. Navy.

The last Navy vessel to bear the name the U.S.S. Wisconsin (BB 64) served in every major U.S. conflict after it was launched in 1944 until it was decommissioned in 1991. Since then, no U.S. Naval vessel has carried the storied Wisconsin name.

Last week, Baldwin and Johnson also led the bipartisan Wisconsin congressional delegation in sending a letter to U.S. Navy Secretary Kenneth Braithwaite requesting the next U.S. Navy submarine be named the U.S.S. Wisconsin.


